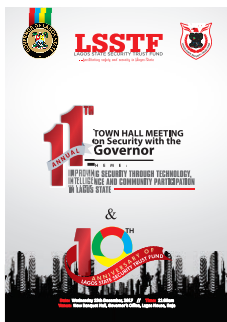

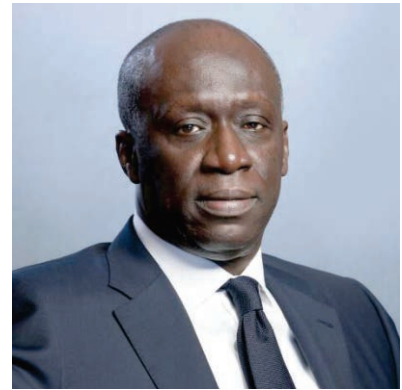

WELCOME ADDRESS BY THE CHAIRMAN, BOARD OF TRUSTEES OF THE LAGOS STATE SECURITY TRUST FUND, AT THE 11TH TOWN HALL MEETING ON SECURITY WITH THE GOVERNOR AND 10TH ANNIVERSARY OF THE LAGOS STATE SECURITY TRUST FUND HELD AT THE BANQUET HALL OF THE GOVERNOR'S OFFICE, LAGOS HOUSE ALAUSA ON WEDNESDAY 13TH DECEMBER 2017.

Protocols,

It is with pleasure that I welcome you all to the 11th Town Hall Meeting on Security with His Excellency and the celebration of the 10th Anniversary of the Lagos State Security Trust Fund

Ten years ago, a meeting of stakeholders was convened at the Civic Centre, Victoria Island championed by prominent captains of industry aimed at finding solutions to the very serious security challenges, largely occasioned by the deficit in operational capacity of the police and other security agencies, in Lagos at the time. This situation had become so grave that it was difficult to carry out regular daily activities without the fear of being attacked by armed robbers. It is instructive to note that Mr. Jim Ovia heeded the call of the then State Governor, Babatunde Raji Fashola and rallied other captains in the private sector to make donations in support of security in the state following the submission by the Security Committee, headed by IGP Musiliu Smith (Rtd.), that security agencies in the state required basic security equipment and logistics to carry out their statutory responsibilities. This

metamorphosed into the Lagos State Security Trust Fund in September 2007, by a Law passed by the Lagos State House of Assembly and quickly became a platform for continued assistance to security agencies operating in Lagos State.

Over the 10 year period, the Fund, which was the first of its kind, has become a source of succor to Lagosians and a shining example of an endearing Public Private Partnership in the country as a whole such that State Governments and even the Federal Government have sought to understudy the Fund so as to replicate it. In fact, a number of States have already set up their own security Trust Funds and a bill to establish that of the Federal Government is at the National Assembly at the moment (i.e. The Police Trust Fund bill).

In line with the Law establishing the Fund, it has undergone a change of baton from its pioneer Board of Trustees and Executive Secretary to the current Board and Executive Secretary. I must acknowledge that the pioneer administrators of the Fund performed excellently to establish a very strong and promising organization which has continued to be relevant in the provision of equipment and logistics for the police and other security agencies operating in Lagos.

Since 2015, the current Board has modified the operations of the Fund to better engage stakeholders in response to the evolving financial climate in Nigeria today. We have met smaller units of decision makers/stakeholders in different sectors of the economy to drive home the need to maintain this partnership which we envisage will make "Lagos - the safest, most secure and most prosperous commercial location in Africa".

At our last meeting, we made it clear that our focus at the Fund was on technology driven solutions to strengthen the security architecture in the state which I am delighted to mention that this is also in line with His Excellency, the Governor's policy trust on security in the state.

A decade is a significant period in the life of any organization, more so one that has impacted the lives of about 21 million people. Undoubtedly, the Fund has achieved a lot and it is apt to celebrate its tenth year of existence. Although, we have not totally reached our goal but we are on track and very optimistic that we will reach our goal with your continuous support. This is therefore a time when we

take stock of our activities and rededicate ourselves to this child of circumstances, as we have collectively resolved to take our destinies in our hands.

Since inception, the Fund has injected over ₦21 billion into the security architecture of Lagos State. The details of which the Executive Secretary had always presented to you at this annual event and he will certainly do so shortly.

In the celebration of our tenth year of operation, we wish to acknowledge all our donors. We thank you so very much because without your support, we would not have achieved all we had. In fact, without our donors, the Fund would have folded up as we do not receive subvention from the State Government. This is yet another opportunity for me to clearly reiterate that the Board of Trustees of the Fund, with the full cooperation of His Excellency the Governor, is completely autonomous and operates outside the bureaucracy of the civil service which enables it to respond quickly to security issues.

To further appreciate our donors, we shall be presenting awards to those that have contributed ₦250 million and above to the Fund in the last one decade. The list of all our donors have been published in the annual report that has been distributed to you already and we urge other organizations to take a cue from their laudable example.

We salute the men and women who put themselves in harms way to ensure we can go about our various activities without fear. We are grateful for your continuous sacrifice and we pledge to continue to do more to make it easier for you to carry out your statutory duties and in commemoration of our 10th Anniversary, we shall be presenting awards and cash gifts to 10 of these outstanding officers.

Our sincere appreciation also goes to His Excellency, Mr. Akiwunmi Ambode for his continued support and understanding. Your continued provision of functional infrastructure makes clear your focus on the overall development of the state and improvement of the living standard of residents of Lagos. It is worthy to note that the Lagos State Government remains the largest donor to the Fund with a contribution of 71% of the total donation to the Fund. We are particularly grateful for your approval to host our 10th anniversary meeting in your office in order to give the occasion the “magic” touch it deserves.

In the light of our anniversary also, we shall have a special paper delivered by Mr. Yomi Zamba on the theme: **“Improving Security through Technology, Intelligence and Community participation in Lagos State”**. The Commissioner of Police, Lagos State Police Command, as always, shall give us a presentation on the security situation in Lagos State and His Excellency will also address us in the course of the programme.

While we urge you to settle down and enjoy the proceedings of today, please be assured that we shall be prudent with time.

Once again, I welcome you all and I thank you in anticipation of your continued and kind support towards the Fund.

REPORT OF THE EXECUTIVE SECRETARY OF THE LAGOS STATE SECURITY TRUST FUND AT THE 11TH TOWN HALL MEETING ON SECURITY WITH THE GOVERNOR AND 10TH ANNIVERSARY OF THE LAGOS STATE SECURITY TRUST FUND HELD AT THE BANQUET HALL OF THE GOVERNOR'S OFFICE, LAGOS HOUSE ALAUSA ON WEDNESDAY 13TH DECEMBER 2017.

Introduction

It is with a combination of passion and honor that I address you this morning at the 11th Town Hall Meeting on Security with the Governor and in celebration of the 10th Anniversary of the Lagos State Security Trust Fund.

Our able Chairman has welcomed you appropriately to today's occasion and I would just like to add that I am delighted that you have honoured our invitation, yet again, which for me demonstrates your approval of our collective resolve to improve the security architecture of the state for the prosperity of all.

We cannot over emphasize that our gathering here today relates to the extremely fundamental aspects of security, which as we can clearly acknowledge, impacts on all the other facets of our governance vision and indeed on all other facets of our lives, particularly our business activities and general quality of life.

It is for this same reason that ten years ago the trust Fund was created by legislation and it is particularly nostalgic for me as I was then the Chief Whip of the Lagos State House of Assembly at the time and I am sincerely grateful to everybody that has contributed to its survival ten years on. Let me also seize this opportunity to thank members of the 6th Assembly in Lagos State for this novel legislation.

Security Challenges in Lagos

Lagos has peculiar security challenges due to its large population density driven largely by economic immigration. At the inception of the Fund bank robberies, home invasions, street robberies, public disorder, cult related murders and car jerking were the major security challenges in the state, but as the years went by kidnaping were added to the list. These crimes made business difficult to pursue and living almost unbearable at that time.

Response of LASG and LSSTF in the Last Ten years

The report of the Security Committee set up by the Lagos State Government revealed that the security personnel in the state possessed great individual ability and were ready to serve but could not deliver due to the lack of equipment and logistics resulting from the underfunding of these agencies by the Federal government and I must thank Alhaji Musiliu Smith, IGP rtd., and 31 other members of that committee for the detailed report which formed the framework for what we celebrate today. We are particularly gladdened that you are still very committed to this collective resolve even after ten years.

The state government therefore took the lead in rallying support for the security agencies operating in the state. As earlier stated, a few private organizations and individuals teamed up with the government and made very valuable contributions towards security in the state. As it is our 10th Anniversary, I must recognize such people like Mr. Jim Ovia (Chairman Zenith Bank Plc.), Mr. Moyo Ajekigbe (former Managing Director, First Bank Plc.), and others who made personal sacrifices to coordinate and muster contributions for the improvement of security at the initial stage.

In order to properly account for these contributions and to have sustainable coordination of future donations the Lagos State Security Trust Fund was established. The pioneer Board ably Chaired by Mr. Remi Makanjuola, Chairman Caverton Helicopters and Marine, with Mr. Fola Arthur-Worrey as Executive Secretary/CEO, gave the Fund the required structure to guarantee its success. I also salute Mr. Kehinde

Durosimi-Etti, DIG Waheed Kassim, Dr. Reuben Abati, Mr. Apollos Ikpobe, Mr. Jide Sanwo-olu, Prince Lanre Balogun, Mr. Ebenezer Onyeagwu, Dr. Ayodele Abina, Mr. Biyi Mabadeje, and Mr. Bisi Onasanya for their contributions as Board members at different times.

Since then, the commitment of the state government in enhancing the security situation in the state has continued to be demonstrated by successive governments in Lagos State. The current administration inspiringly led by His Excellency, Mr. Akinwunmi Ambode demonstrated even more vigor by making security the centre of its tripod agenda and made the single highest donation in the history of any state in Nigeria of 4.6 billion in assets to security agencies through the Fund in November 2015 leaving no one in doubt as to its dedication to the provision of improved security in the state.

Our collective efforts raised 21.2 billion in cash and kind in ten years which translates to 3 helicopters, 1184 Patrol vehicles, 45 Armoured Personnel Carriers(APCs), 459 Motorbikes, 25 Patrol Boats, 1697 Tyres, 750 Batteries (vehicular), 126 Generator (various capacities), 660 Riders Gear (suits, helmets, and boots), 1945 Bulletproof vests, 2605 Ballistic Helmets, 5046 Rain Gear (Coats and boots), 1000 Police hand gloves, 6487 Uniform material (17600mtrs/240 rolls), 1500 Sweaters, 1250 Leather boots, 558 Walkie Talkies, 30 Explosive Detection kits, 100 Gun Shot Trauma treatment packs, 10 Walkthrough Scanners, 122 Portable Cameras (Nikon 16MP 4G memory Card), 12,998 Disposable handcuffs, 500 Stun gun batons, 20 Garret hand-held metal detector(s), 100 Stainless handcuffs, 10 Underneath vehicle scanners, 10 Knapsack sprays, 500 Metal hand cuffs, 50 units Motorized search lights, 20 units Go light Military Search lights, 1000 units(each) Mattress & pillows, 1000 Bunk beds amongst others. This is distinct from all other support the Lagos State Government has been rendering independent of the Fund.

The Fund is also responsible for repairs, maintenance, fueling and other logistics that ensure daily operations of security agencies in the state. This is a key element of sustainability and, if I may say, the major challenge of our nation. We are fairly good at buying equipment but ensuring that they run efficiently is a challenge. In ten years about N4.5 billion have been spent on fuel (AGO, PMS) and lubricants alone as each patrol vehicles receives at least 20 liters daily, also AGO is provided for the Navy and the Marine Police for their daily operations in addition to its provision for Armoured Personnel

Carriers. Training and re training of security officers especially the RRS is also part of the critical roles performed by the Fund.

In all these we should note, as the Chairman said earlier, the Lagos State Government is the biggest donor to the Fund with a contribution of 71% while the private sector contributed 29%. This further underscores the premium the current administration in the state places on security of lives and property

Activities of the Fund in the current year

In the period since the last Town Hall, the Fund had concentrated on engaging groups that were never before directly engaged before such as the members of the Association of Tradesmen and Technicians in the state, the Heads of Security/ Chief Security Officers of notable organizations and Embassies in the state, and Private Security Companies. These meetings were well attended and we were able to secure the buy in of the attendees. In fact, the United States and Canadian Embassies have subsequently offered us some technical support and pledged to look at other areas of support including donation of equipment where possible.

We also held an appreciation dinner for CEOs of Banks who have continued to make donations and support over the years to the Fund. The dinner was hosted by His Excellency the Governor.

In addition, we held a few media parleys and paid several courtesy visits to media houses and other organizations. One of the contributions we got from these visits was 13 episodes of a 30 min live show tagged "Security and You" on Lagos Talks 91.3 FM pro bono. The programme was later extended to 18 episodes and is currently being considered for another quarter because of its appeal to the public. This helped to further propagate the activities of the Fund to the citizens and enlightened them on security matters for which we are immensely grateful to Megalectrics.

The Fund received a few awards in the last one year notable of which is the Businessday Award for "Most Innovative Charity or NGO" a category we were told no government organization had ever been considered for.

During the period, the Fund received donations of about 424 million in cash from which we were able to provide 30 patrol vehicles, 3 units of 200HP Yamaha outboard boat engines, 120 generators, 332 tyres, 250 riders gear, 250 operational boot, AGO, PMS, base radios, uniforms among others. The fund also focused on maintenance and refurbishment of RRS patrol

vehicles, Armoured Personnel Carriers and Marine Police boat.

Security is very expensive and for us to have the level of security enjoyed in Lagos today, it should be clear by now that the administration of the LSSTF must be very pragmatic at all times.

Impact of our collective contributions so far

The direct impact of our combined intervention is that Lagos is now the most secure state in Nigeria, night life is back, and several social and commercial events are now held at night. Lagos has continued to maintain its position as the Land of prosperity which attracts all and sundry. We have been able to enable the security agencies to prevent terrorist attacks in our state. Security in our public schools has greatly improved and security protocols have been put in place. The state boasts of the only functional emergency call centre in Nigeria, which citizens can call toll free (767 or 112) in case of emergency. The marine police fleet has been increased from 6 to 28 gun boats in order to curb the attacks from the waterways. There is relative calm and residents can go about their lawful activities. Investments have grown astronomically in Lagos – several new hotels, new banks, multinational organizations, food and supermarket chains all across Lagos even in areas that were once considered rural. There is massive increase in investments, both foreign and domestic. Lagos takes the lead in almost every aspect of the economy and governance. It is almost as if you have to check “if and how” an idea has been implemented in Lagos before doing same in other parts of the country. Lagos is indeed the “Centre of Excellence”!

The full details of our impact on our security agencies is as contained in the reports of the Commissioner of Police, Lagos State, the OP MESA, the Marine Police and the Rapid Response Squad in this brochure.

LASG/LSSTF Strategy and Way Forward

As the current Board of the Fund assumed office in the thick of the economic recession, we immediately realized that we had to think outside the box to continue to improve security in the state. The Board therefore instituted standing committees to handle different aspects of management and fund raising. In 2017, the Fund put more efforts into producing PowerPoint presentations that properly articulated the challenges of funding security and how critical

the Fund's responsibilities are to the effective operations of security agencies in Lagos State. In simple words “if you want to go back to the days of anarchy shutdown the LSSTF”.

The fact that most states and even the Federal Government are replicating the LSSTF confirms that there is still no alternative to the security funding model in Lagos State. As pioneers, we must continue to reinvent the wheel so as to ensure we are the safest and most prosperous state in Nigeria.

The Government of Lagos State led by His Excellency, Mr. Akinwunmi Ambode, has hinged its administration's agenda on a tripod- Security, Job creation and Infrastructural Development, in recognition of the correlation between security and the economic development. The dividends of this model has manifested in the construction of bridges (e.g in Abule Egba, Ajah, Aboru), laybys in (Iyana Oworo, Ojodu berger etc), massive constructions/rehabilitation of roads, health centers, vocational centers, housing units, etc. Also agricultural advancement, cooperatives and joint venture (LAKE Rice), Light up Lagos Project, overhaul of the waste disposal system - the cleaner Lagos initiative, the Neighbourhood Safety Crops (which is a grass root security outfit providing jobs for over 5700 people), the Environmental Corps which will provide about 27,000 and so on. Worthy of mention is the Lagos State Employment Trust Fund which has assisted thousands of Small and Medium Enterprises (SMEs) with loans. All these developmental projects by the state government are ways to provide more opportunities and a conducive environment which has ultimately dissuaded people from embracing crime and emphasizes the United Nations concept of Human Security.

We also appreciate that in order to achieve the best level of security, we must look to technology and I am pleased to state that the state government has provided leadership in this direction too. The state has provided drones, tracking devices, robotic bomb disposal devices, high grade CCTV cameras, amongst others for security agencies. In collaboration with the state government, we are in the process of procuring surveillance aircrafts with high-tech 3D cameras all in a bid to ensure our citizens are safe.

Funding Challenges and needs assessment

While we accept that a lot has been done, we recognize that a lot more still needs to be done and security equipment are not cheap to acquire or maintain.

First of all the vehicles currently in use by security agencies in the state (about 600 of them) were purchased over a period of time. Considering that the average life span of these security vehicles is 3 years, even the vehicles purchased in 2015 will be due for replacement in 2018.

Secondly, costs of acquisition and maintenance have gone up largely due to the increase in foreign exchange rates since the equipment and their spare parts are imported. Also the price of fuel - petrol and diesel have gone up. An example of the challenge of maintenance is the quality of diesel available in the Nigerian market. Most of our Armoured Personnel Carriers (APCs) run on diesel and bad diesel often affect the fuel pump leading to damage and eventual replacement. A fuel pump for our Ford 550 APC cost N 250,000.00, (a fact you can verify on the web). We should also note that one billion naira can only procure 55 patrol vehicles (at N18 million each) which are not enough for distribution to all the 57 Local Government and Local Council Development Area in the state which further underscore the capital intensive nature of providing security infrastructure.

In addition, there is constant improvement in technology therefore upgrades take place from time to time. One of such is the recent switch by the Lagos State Police Command with the support of the Fund and the Lagos State Government from an analogue communication system to a digital system which means their walkie talkies and base radio sets must be changed to digital radio sets. In the same vein, higher quality drones are required. Though a good number of security agents are now well kitted, quite a few still require kiting – Bulletproof vests, firearms, handcuffs, uniforms, boots, touch lights, search lights, collapsible batons, teasers, riders' gear, etc.

Other critical equipment urgently required by the police especially to minimize casualties during public disturbances include water cannons, automatically deployed barriers, anti riot gear, tear gas, rubber bullets etc. There is need for a database of offenders which will require equipment - cameras, computers, servers, network services, etc.

Going by the security budgets in your respective organizations and estates I am sure you know that Security is a very expensive endeavour. Therefore, we must guard jealously this collective enterprise to ensure that our children and other loved ones can live their dreams without any worry about criminals disrupting their activities or the unthinkable - cutting short their lives in their prime.

Conclusion

It is pertinent to note that without a constant flow of donations on an annual basis the Fund cannot make adequate plans for the magnitude of requests received from security agencies in the state. We therefore need organizations to commit to a consistent and sustainable donation model which can help strategic planning for improved security in Lagos State. This year there has been donor fatigue or apathy due to the recession, but as we approach 2018 which precedes the general elections of 2019, it is important that all hands must be on deck to keep our city safe. Therefore, I passionately appeal to corporations and individuals who are yet to come onboard to make contributions to the Fund, while our partners who had not contributed to the Fund in a while should please reconsider and resume their donations as all contributions are well accounted for and as always, we commit to the judicious use of these resources.

On this note, I wish to thank His Excellency, the Governor for the clear direction of his vision in making Lagos one of the safest and most prosperous commercial destination in Nigeria. Your commitment and zero interference in our activities have ensured high efficiency in the discharge of the mandate of the Fund and we are indeed grateful for this uncommon leadership style. My gratitude also goes to the Chairman and other members of the Board of Trustees of the Fund for their sacrifice and dedication to duty.

I must also appreciate our law enforcement agents and security personnel who continue to risk their lives to keep us safe and the good people of Lagos State for their support and cooperation.

I am immensely grateful to our esteemed donors who have continued to contribute to the Fund, year on year, in the realization that this is in our enlightened self-interest, while I urge others to step up and play their part by contributing whatever you can – cash, equipment, technical ability, referrals, recommendations “Anything” in order to guarantee the prosperity of all!

I wish you all a merry Christmas and a prosperous new year!!

A REPORT ON THE ACTIVITIES OF LAGOS STATE POLICE COMMAND FROM JAN. TO OCT., 2017
 BY **Ag. CP EDGAL O. IMOHIRI**, THE COMMISSIONER OF POLICE, LAGOS STATE POLICE COMMAND, IKEJA.

INTRODUCTION

- I consider it a great privilege to be part of this 11th Town Hall Meeting on security organized by the Lagos State Security Trust Fund. This year's meeting is unique in some way, the reason is not far-fetched. It is the 10th Anniversary of the Lagos State Security Trust Fund.
- Lagos State with an estimated population of **twenty-two (22) million** has thirteen Police Area Commands and one hundred and seven Police Divisions, making it the biggest police command in the country.
- The State due to its economic and socio-political importance in the country keeps attracting migration of people and this has made it to have its fair share of security challenges.
- Regardless of the phobia for perpetual increase in crime and criminality in the state in view of its peculiar nature, it is delighting to note that the State Government, the Police, other security agencies and stakeholders have partnered to make the State generally safe for all and sundry. This has led to negation of the phobia.

THE REMARKABLE ACHIEVEMENTS

RECORDED DURING THE PERIOD

- Before my appointment as the Acting Commissioner of Police, Lagos State, you will recall that the Lagos State Police Command, was faced with two major security challenges, i.e The **Badoo cult group** carrying out ritual killings within Ikorodu and its environ and the militant group carrying out kidnapping within schools in Epe, Ikorodu and other parts of the state.
- As the Deputy Commissioner of Police Operations, Lagos State Police Command, I mobilized a joint security operation, involving members of Onyabo Vigilante Groups, the Oodua Progress Congress (OPC), led by Chief Gani Adams, the Departments of State Security (DSS), Lagos Neighborhood Safety Corps (LNSC) e.t.c who I had series of meetings with at the Command Headquarters' Conference Hall, Ikeja and we all came up with a blueprint on how to tackle the Badoo menace.
- Joint security patrols were carried out at night within the nooks and crannies of Ikorodu by security agents.
- While traditionalists, including Local Chiefs and Baales, within Ikorodu community and its environ, were given stern warning during a night-watch meeting, that they would be held responsible for any reports of ritual killing by the Badoo cult groups in their domains.
- This strategy paid off; as it brought to an end the Badoo activities in Ikorodu and also aided the discoveries of suspected notorious shrines within Ikorodu and its environs, used for ritual killing purposes, which were eventually demolished.
- Also, as the Deputy Commissioner of Police Operations I led various police teams that gave the militants terrorizing communities within Festac, Iba, Isheri-Osun, Epe and Ikorodu areas of Lagos State for a long time, a huge fight, forcing them to flee Lagos State and its waterways.
- The militants met their waterloo after they invaded the Lagos Model College, Igbonla, Epe, on 25th May, 2017 abducted six (6) students, who they kept in their captivity. But were ambushed and killed in their large numbers, when they attempted to snatch Marine Police gunboats.
- That operation inflicted a heavy blow on the militant group, which also led to the death of its leader known as America.

- I can assure you that militant groups have been degraded and denied the capability of attacking our schools, communities and waterways.
- Since my assumption of office as the Commissioner of Police, Lagos State Command in September 2017, I leveraged on the robust goodwill existing between the Police and the State Government on one hand and members of the public on the other, to record some modest achievements, that have not only consolidated that of my predecessors, but has ensured that the Command keeps the flag flying.
- I hit the ground running by initiating and attended eleven (11) Town Hall meetings where I introduced my policing plan to Lagosians. A plan powered by the philosophy of community policing and community safety partnership.
- I am happy to inform the house that the strategy is *working and* there has been a drastic reduction in crimes generally in the state, especially car snatching, armed robbery, kidnapping, cultism et al.
- This is also attributable to the collaboration and contributions of Lagos State Government through the Lagos State Security Trust Fund (LSSTF) in the provision of logistics supports to the Command.
- From January to October, 2017; a total of Two Hundred and Ninety-Nine (**299**) armed robbers were arrested while Thirty-Two (**32**) others died during encounters with the police. Two Hundred and Thirty-One (**231**) vehicles were recovered during the period. Twenty-One (**21**) armed robbery attempts were foiled.
- Regrettably, Six (**6**) Police Officers were shot dead in the line of duty. Find below other notable achievements recorded during the period under review.
- On 25th August, 2017 at about 0600hrs one armed robber named Femi a.k.a Lighter died as a result of bullet wound he received during a gun duel with the Police in Alagbado area of Lagos, while two(2) others, namely Segun Egan 'm' and Lucky Sanmi 'm', were arrested. The following exhibits were recovered from them: Two (2) locally made pistols, Four (4) telephone handsets, Two (2) live and two (2) expended cartridges.
- On 28th August, 2017 at about 1200hrs one Felix Balogun 'm' of Jakande Estate Lekki was arrested when he broke into the residence of one Tunji Olayode 'm' of the same address. On interrogation, he confessed to the gang's hideout where thirteen (13) members of the gang were apprehended including a female. The following items were recovered from them: One Locally Made Pistol, Two Cutlasses and a battle axe, Two (2) Live Cartridges, Assorted Charms
- On 20th September, 2017, the CP personally led policemen to locate and destroy Five (5) shrines in Imota and Agbowa areas in Ikorodu notorious for criminal activities such as kidnapping, ritual killing and extortion during the operation, one Mr and Mrs Babatunde Hassan were rescued in Agbowa, while one James Adedeji was arrested.
- On 25th September, 2017, information received from a reliable source that some group of armed robbers and car snatchers led by one Onyekachi Osunkwo, had in their possession four (4) stolen vehicles and they were about taking them to the eastern part of the country for sale. Police Operatives of the Command were mobilized to intercept the suspects. This operation led to the arrest of the suspects and recovery of three (3) vehicles (i) **Toyota Sienna Bus** with Reg. No. **LSR 246 EL** (ii) **Toyota Sienna Bus** with Reg. No. **EKY 434 CA** (iii) **Toyota Corolla Saloon Car** with Reg. No. **APP 09 SN**.
- On the 8th October, 2017 intelligence was received that a gang of armed robbers terrorizing Ijede, Ikorodu and robbing innocent citizens were hibernating in their hideout at No. 41, Egbin area of Ijede, Ikorodu Lagos. Based on the information, SARS Operatives from the Command stormed their hideout and arrested one Ayinla Azeez 'm' the gang leader and nine (9) others namely **Ayinla Azeez 'm'** age 22yrs, **Balogun Yinka 'm'** age 20yrs, **Begusa Peter Oluwasegun 'm'** age 32yrs, **Omolaja Oluwafemi 'm'** age 29yrs, **Godday Samuel 'm'** 19yrs, **Dennis Ifeanyi 'm'** age 34yrs, **Ogunsanya Yusuf 'm'** age 27yrs, **Odubanjo Akeem 'm'** Age 35yrs, **Damilola Ogunbadero 'm'** 20yrs, **Dayo Tedunjaiye 'm'** age 23yrs. They all confessed to be "Aiye Confraternity" cult members. **one locally made revolver pistol with five (5) rounds of live ammunitions, one locally made cut to size double barrel gun, one locally made cut to size single barrel gun, two (2) locally made**

single barrel pistols with three (3) live cartridges, one locally made axe, one axe and one plier were recovered.

- On 14/10/2017, The Lagos State Police Command, after weeks of intensive manhunt arrested one Ismail Adeyemi 'm' aged 49yrs, the suspected mastermind and killer of **Hector Jobateh (The 2006 winner of Gulder Ultimate Search)** he confessed to the crime and admitted to other various criminal activities within the state. The Suspect led Operatives to Sango Gas-line, Ijoko where his operational revolver pistols with nine (9) rounds of live ammunitions were recovered.
- Similarly, based on intelligence, the Lagos State Police Command embarked on an intensive raid of criminal hide-outs around Akala, Mushin, Idi-Oro, Oju-Elegba and Iyana-Ipaja across the Lagos State leading to the arrest of over fifty-six (56) suspects and recovering of hard drugs
- On Tuesday 17th October , 2017 the Command embarked on the destruction of all the seized illicit/Narcotic drug substances with estimated value of about Fifty Million (N50,000,000) Naira
- On 21st October, 2017 at about 2300hrs, based on intelligence, three (3) suspected armed men namely:- William Olowoju, 'm', Ayo Akinola, 'm', and Segun Teluwo, 'm', were tracked and arrested at their hideout at Agodo Alara-Ogijo in Ogun State. Suspects allegedly kidnapped one Hillary Chukwu Dumebi and Rebecca Omokaro 'f', from their residence at Oniru Private Estate Victoria Island, Lagos
- On 30th October, 2017, Operatives of the Command acting on further information from the members of public arrested one Babatunde Azzez 'm', a suspected Cocaine dealer at No. 6, Palm Church Street Lagos Island. Substances suspected to be cocaine was found in his possession, suspect confessed to the crime. Also recovered at peti Lagos Island is a large cache of weed suspected to be Indian hemp. Both Narcotic substances are stated to have a street value of over Three Million Naira.
- On 31st October 2017, at about 0130hrs, at Oshodi and Orile Iganmu area, six (6) suspected armed hoodlums namely one Ibrahim Olowo 'm' age 35yrs, Wasiu Arogundade 'm' age 40yrs, Olawale Okoosi a.k.a **No Story** 'm' age 35yrs,

Taiwo Sanni a.k.a **Ejima** 'm' age 38yrs, Ojo Mutiu 'm' age 36yrs and Olasunkumi Ogundele 'm' age 40yrs were arrested for terrorising and causing of breach of public peace.

- Three (3) pump action guns, Three locally made guns were recovered.
- From January to August 2017, there was 15% decline in crime rate, while the introduction of community policing/safety partnership and the increase in police visibility between 1st September to 31st October 2017 has resulted in 35% decline crime in Lagos State
- The Acting Commissioner of Police in order to ensure a firm take off of the above mentioned strategies in all communities in Lagos embarked on various Town Hall Security Meetings covering about Eleven (11) Area Commands to sell his security plan to the people. The meetings were well attended by members of the public across the state and feedback has been tremendous **and has led to the discovery and onslaught of criminal dens in the state.**

TRAFFIC MANAGEMENT REFORMS BY MY ADMINISTRATION

As regard traffic management reforms:

- In the area of traffic control management, the CP within this first month introduced a standard dress code outfit for all traffic control personnel to include the reflective jackets and white hand sleeves to promote uniformity.
- On 14/10/2017, I pulled-out over Six Hundred (600) man strong Supernumerary Police Officers (SPY) for partnership to ensure effective traffic control especially on weekend where every major junctions in the state should have traffic control officers to ensure free flow of traffic.
- Courtesy visit to Lagos State Transport Management Agency (LASTMA) where a memorandum of understanding(MOU) was signed on how to ensure free flow of traffic and proper utilization of manpower asset thereby forming a strong synergy for effective general traffic management in the state.
- Also the Command is partnering with the Federal Road Safety Corps (FRSC) for the effective traffic management on the highways.

STRATEGIES EMPLACED TO FIGHT CRIME

- To ensure a low crime rate is sustained, increased police presence in all crime prone areas and other locations has been implemented. The Command is not only proactive in nature but intelligence-driven. Other strategies emplaced are:
- Re-invigoration of the intelligence gathering mechanism of the state and information sharing among security agencies;
- Purposeful and constant joint raids with personnel of the Lagos State Neighborhood corps, Vigilante and DSS of identified criminal hideouts and black spots;
- To win the trust and confidence of Lagosians, the CP urgently set-up the Citizens Complaint Hot Centre at the Police Intelligence Laboratory Alausa. Features of the centre include TEN (10) dedicated lines where members of the public can call, text and their matters can be urgently attended to.
- Training and retraining of the officers on Human Rights, Election duty, Counter Terrorism, emergency response and combat operation readiness;
- Deployment of Counter Terrorism Unit and Bomb Squad personnel at key locations;
- Dissemination of the telephone numbers of the Area Commanders, Divisional Police Officers and other Principal Officers to the members of the public to enhance information flow to the police;
- Upon intelligence of an imminent breach of public peace, the Command constantly dialogues and encourages dialogue among warring groups;
- Prompt investigation and prosecution of all reported cases;
- Maintenance of robust working relationship with the Military and other security agencies;
- Aerial patrols by helicopters using the three multi-purpose helicopters acquired for the Command by the Lagos State Government;
- In conjunction with the State Government members of the NURTW and RTEAN have been made to understand that forceful taking over of motor parks will no longer be tolerated, except in line with the constitution of the unions. Where

such occurs, the aggressors are promptly dislodged by the Command and advised to follow the due process;

- The government should on its part, sensitize the citizenry, that human life is sacrosanct.

CHALLENGES/CONSTRAINTS

- However, despite the massive contributions of the LSSTF to the Command, dearth of patrol vehicles remains a great challenge;
- Many vehicles attached to the divisions have become rickety and unserviceable due to old age and over usage;
- Another challenge is the frequent breakdown of the Command's communication system, thus, hindering operations and anti-crime activities. Currently, the Command has only two repeaters bases situated at NITEL building Marina and Alausa.
- The one at Marina is too old, develops faults at random and makes radio communication extremely difficult;

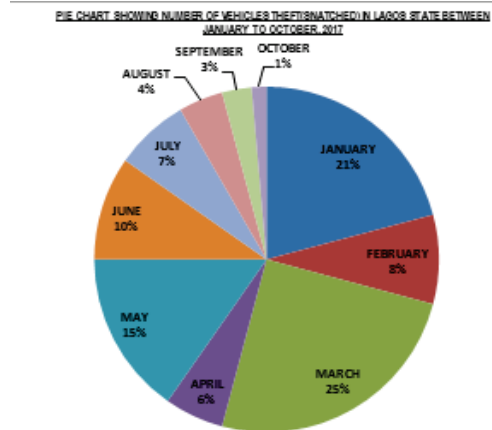
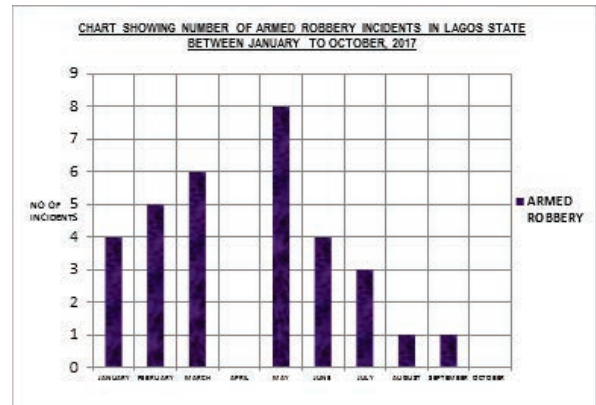
As a remedy, the following are the urgent logistics need of the Command:-

- **COMMUNICATION:**
 - Three (3) Motorola MTR2000 Repeaters, 100w heavy duty mood with cooling system;
 - Three (3) 9DB gain heavy duty Omni-directional Antenna for MTR2000 repeater;
 - Three (3) 100m Heliac low loss cable
 - One (1) 3db gain Antenna for the existing base station in Maroko Police Station
 - Four (4) 1.5 KVA Inverter (Maroko and Marina)
 - Eight (8) 200mAH Heavy duty Lead Alkaline battery (Maroko, Marina and 2 other new repeaters)
 - Three (3) 'U' Bracket for Antenna Installation
 - Three (3) Installation (tuning and Programming)
 - Four Thousand (4,000) walkie-talkies;

- One hundred and fifty (150) Base Sets;
- Four (4) new repeaters, each with 60KVA generator and back-up batteries

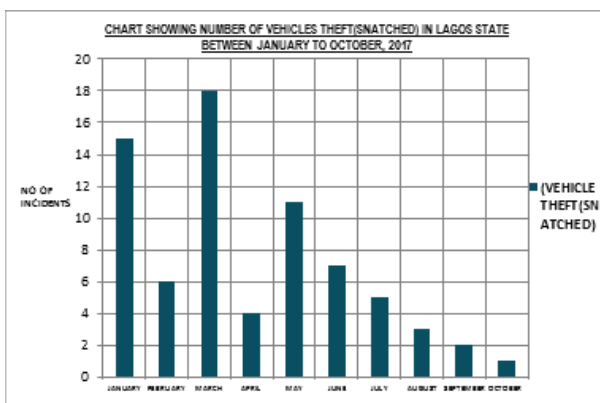
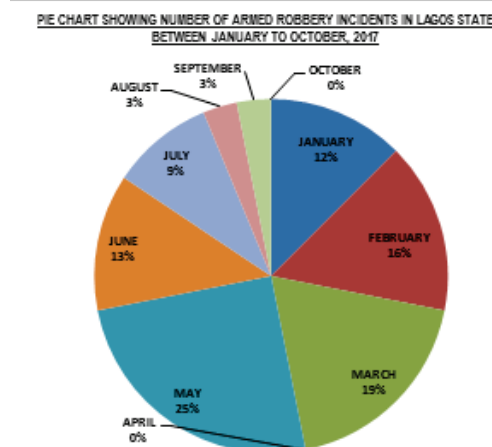
➤ **PATROL VEHICLES/MOTORCYCLES:**

- 200 patrol vehicles, equipped with communication gadgets;
- 5 lorries (troop carriers);
- 5 heavy duty towing vehicles.
- Other logistics requirements include arms and ammunition, riot gunners, smoke pistols, hand grenades, tear gas canister, thunder blasts, bullet proof vests, ballistic helmets, respirators, etc.

A BRIEF ON THE ACTIVITIES OF THE RAPID RESPONSE SQUAD



The Origin of the Rapid Response Squad

What today has blossomed into the ubiquitous Rapid Response Squad (RRS), a unit of the Lagos State Police Command, started out as “Operation Sweep”, a joint Army, Air Force cum Police crack teams, to combat the then growing rate of crime in the metropolis during the administration of Colonel Buba Marwa.

The administration of Asiwaju Bola Ahmed Tinubu in repositioning and adding bite to the force, rechristened it, Rapid Response Squad after restructuring it. The administration allowed the Nigerian Police to assume total responsibility of the services of RRS in order to reflect the new democratic dispensation at that time.

Building on the strides of his predecessor, Governor Babatunde Raji Fashola injected Public-Private Partnership by setting up a committee headed by the former Inspector General of Police Musiliu Smith to look into ways and means of combating the growing menace of violent crimes in the state. Part of the item contained in the committee report which was subsequently passed by the Lagos State House of Assembly was the Lagos State Security Trust Fund, with an Executive Secretary to coordinate its affairs. His Excellency Governor Akinwunmi Ambode whose administration is hinged on a tripod of Security, Job Creation and Infrastructure Development and perhaps, steaming from the fact that manning the city and the state is the very first step to developing it, and that there cannot be genuine development without commensurable investment in security, led to the rebranding of RRS in November 2015 through the Lagos State Security Trust Fund and procurement of 100 patrol cars; 55 Ford Range Pick-

ups; 10 Toyota Land Cruiser pick-up; 15 BMW Power Bikes; 100 Power Bikes, Izuzu Trucks; 3 Helicopters; 2 Gun Boats; 15 Armored Personnel carriers; Radio Communication gadgets, helmets, bullet proof vests, insurance benefits; death benefit scheme among others amounting to N4.8 Billion.

Predominantly, RRS and its personnel have been enjoying ceaseless support from the administration of His Excellency, Governor Akinwunmi Ambode as well as the continued funding from the Lagos State Security Trust Fund as the Fund is the backbone of its operations and responsible for the maintenance, repairs, logistics and other consumables of the RRS equipment, vehicles, power bikes, Armoured Personnel Carriers (APCs), communication gadgets etc.

Since its creation, RRS has had 5 Commanders with Tunde Sobulo (2001-2004) as the pioneering Commander; Kayode Egbetokun (2005-2007); ACP Olusegun Odumosu (July, 2007-Jan. 2015); Csp Samuel Awopetu (Jan. 2015-May, 2015) and the resourceful and energetic ACP Olatunji Disu as its current Commander since June 2015.

Achievement

Rapid Response Squad's achievement in almost two years of its rebranding by His Excellency, Governor Akinwunmi Ambode, has been extremely dramatic, unique in terms of zeal injected into service delivery by its leadership and officers and the swiftness of its response time to crime as well as emergencies across the state. RRS's achievements are too numerous to be confined into a short essay but here are few tips of its ground-breaking successes since it was rebranded.

Re-orientation and investment in Modern Policing Technique

It is a common sight to see RRS officers assisting members of the Public in need of assistance, particularly those with broken down vehicles in bad spots and at odd hours. There are vestiges of its attitudinal changes RRS leadership with the support of the Lagos State Security Trust Fund has been promoting: attitudes that make officers recognize that the satisfaction and safety of people is the basis of policing.

RRS is re-creating a force that respects members of the public while discharging their duties. With the assistance of the Lagos State Security Trust Fund, RRS

has trained and retrained its officers to be alive to their duties and that is why the RRS is called Elite Police or the Good Guys.

Unraveling Murder case: one of the astounding murder case RRS unraveled this year was the chilling killing of 50 year old Mabel Mba Okafor, a Bureau De change owner who lived in J68B close 9, Victoria Garden City in Ajah area of Lagos on Wednesday August 17.

The case was turned over to RRS to crack. For a week, RRS Decoy team J were in Bali, Taraba State in search of the prime suspect, Tanko Abdulateef the 22 year old guard of Late Mrs. Mba-Okafor. Tanko who confessed after he was arrested with two mobile phones of his late boss and several other personal effects, that he killed her by ripping her stomach with secateurs.

New Technology Policing: RRS has taken policing beyond the traditional conventional means of crime detection and botching. The Squad is leveraging on new technologies like drone surveillance, phone and social media tracking and internet fraud to bring suspected hackers to justice.

Some of its landmark cases in this area include: the cracking of over three bank fraud cases, two cases of stolen ATM cars with amount grossing N4 million, recovery of over N50 million worth of stolen jewelry, arrest of several hackers.

Vehicles Tracking: in less than two years of its rebranding, RRS has traced, tracked and recovered over 70 vehicles stolen within and outside the State. A noteworthy case here is the recovery of 8 cars at the palatial house of an Abeokuta based chief in 2016. In 2017, six vehicles were recovered from a robbery syndicate after they were sold to an Onitsha based auto dealer.

Search and Rescue of Bristow Crashed Chopper: RRS helicopter was the first to spot the Bristow helicopter that forced-landed on the ocean in February, 2016.

Arrest of Kidnappers: Apart from foiling several kidnap cases, several kidnap suspects were arrested by the Decoy Team of the RRS. One of the most spectacular of such profile cases was the arrest of the prime suspect in the kidnap of Senator Iyabo Anisulowo in Festac, Lagos.

Other cases were, Blessing Yanyanbin, who kidnapped a Chinese national in Ikorodu. Another Godwin was arrested in Warri, Delta State in connection with a kidnapping incidence in Iju-Fagba, Lagos.



One of the astounding murder cases RRS unraveled this year was the chilling killing of 50 year old Mabel Mba Okafor, a Bureau De change owner who lived in J68B close 9, Victoria Garden City in Ajah area of Lagos on Wednesday August 17.

Bank Fraud: Several cases bordering on of bank fraud have been cracked by the RRS leading to the arrest of several suspects and colluding bank staff. Some of the prominent ones are: N150 Million bank fraud with the arrest of suspects like Israel Ochenhi; Pater Ezerupe; Obeeny Udeme; Winners Golden Bet fraud amounting to N5 Million, amongst others.

Recovery of Stolen Laptops, Phones and Arrest of Robbers: RRS arrested several dealers of stolen phones across the State mostly from Ajegunle and computer village leading to the recovery of several stolen phones; thus leading to arrest of many armed robbers, "one chance" gang and pickpockets. Suspects in this category include Kazeem Bamidele a.k.a Elewure, Ikemefuna Aje, Prince Agabi Okanu, Kazeem Damiduro, Ubeke Micheal, Obinna Okoro, Akeem Fatai, Jerry Nwokoro etc.

These achievements could not have been possible without the ultimate sacrifice and co-operation of our officers. In almost two years, two officers from our Decoy Team suffered gunshot from robbers in their leg and thigh, some of our riders and patrol vehicles were also hit and wounded by reckless drivers and more that 11 officers, in 2017 alone, died in active duty.

While we appreciate His Excellency, Mr. Akinwunmi Ambode for always coming to the aid of our wounded officers and the family of deceased officers by paying N10 Million to each family of the dead and Lagos State Security Trust Fund for equally coming to the aid of RRS in providing all necessary equipment and logistics for the squad as at when due. We emphasize that RRS still needs more patrol vehicles, towing vehicles, protective gear, drones etc.

In a not too distance future, we expect an RRS that gets to scenes of emergencies and crises almost instantly. Our vision for the future is that of a much more secured Mega City with reduced crime rate.

A BRIEF ON THE ACTIVITIES OF THE MARINE POLICE



A brief on the activities of the Marine Police, Lagos State Command

Introduction

The Marine Police was established in the year 1891 in Lagos, Nigeria and was then named “Night Water Patrol”. Though, the Marine Section had its peculiarities, it is regarded as part of regular Police division and are saddled with basic operational duties such as Anti-smuggling patrol, Anti-vandal, Anti-Piracy, Militancy/Kidnapping operations, Enforcement of ports, Harbor and Shipping Acts, Guards, Escorts duties, Election duties, surveillance and general anti-crime duties.

The Marine section generally conduct security combat and anti-crime operations in territorial inland waters (measuring from the inward limit of the coastal waterways to the fairway buoy), Ports and Harbors. The basic and ancillary powers and authority of the section are from the constitution of the Federal Republic, Police Act and various Acts and legislations.

The Department's Activities

The proactive measures taken within the period under review aimed at ensuring safety and security of lives and properties within the waterways of Lagos state have reduced crime. The success was made through intensive waterways patrol, quick response to distress calls, visibility of Police boats in vulnerable areas, surveillance and monitoring of all activities within the waterways.

In recent times, the issue of Security threat has been predominantly recorded in Ise and Epe environs

where Militants, kidnapers and Sea Pirates from Neighboring States gain access through creek to commit crimes in Lagos State. But, the Department through its committed and consistent combat efforts at raiding criminals from the waterways in partnership with AIG Zone 2, and the State Government has helped in making Lagos Waterways safer.

Some of the department's outstanding feats are presented below;

- The Marine Police in ensuring that militants are flushed out of the creeks of Lagos State, on May 2nd 2017, deployed two Police gunboats manned by men of the Marine Police and one backup boat manned by volunteers/pointers to Ikorodu axis on special duty. In the course of their duty, they recovered two service tanks, two Navy camouflaged bullet proof vests, 8 elements, 1 W23 fiber boats, 7 Police bullet proof vests and one 200HP Yamaha engine at Majidun creek in Ikorodu, Iga at about 1000hrs, the recovered/abandoned items were handed over to OC SARS Ikorodu.
- In the course of the rescue mission of the abducted students of the State Model College Igbonla in Epe L.G.A of Lagos, the Marine Police on 26th May 2017 where the Marine Police had a bloody encounter with a Gun duel with militant/kidnappers for over six hours after which over 20 of these militants/kidnappers were killed, 2 of their boats were sunk, 5 Police men and 4 Local vigilante men were seriously wounded, while a member of the local vigilante died.
- The Marine Police responded to information on the snatching of a Cruise Boat at gunpoint around Ikorodu waterfront on the 29th September 2017 and on sighting the Police Gunboat stationed in the area, the pirates opened fire but the greater response of the Police overpowered theirs, the criminals abandoned the boat and escaped with bullet wounds. The Boat "MV BADOORE TARZAN" fitted with 200HP Yamaha outboard engine was recovered.

Some of the activities of the Marine police include: institution of pin down points along the

waterways, engaging in enlightenment/awareness campaigns on safety conducts along the waterways and also carrying out search and rescue operations.

Role of the Lagos State Security Trust Fund and the Lagos State Government

It is important to state that the success made so far by the Marine Police Lagos State Command in combating criminality along Lagos waterways, is piloted by the Lagos State Security Trust Fund. The Fund provides enormous support to the Marine Police to ensure adequate security coverage on our waterways, through periodic servicing of the Gunboats, provision of 200HP Yamaha outboard engines for Gunboats, provision of life jackets, life buoys, fire extinguishers and most importantly AGO (diesel) for the running of the Armoured Combat Patrol Gunboats, and PMS (petrol) for the Fibre Gunboats and other back up boats.

Recently, the Lagos State Government through His Excellency, Mr. Akinwunmi Ambode provided the department with 8 Fibre Gunboats fitted with double 200HP Yamaha outboard engine and 2 other back up boats mounted with 75HP Yamaha engines, for the Marine Police. The Department sincerely appreciates the effort of the Governor of Lagos State and the Lagos State Security Trust Fund in every area; they have been of immense assistance to the Marine Police. Other Non-Governmental organizations should emulate this benevolence and come to the aid of the Marine Police, working towards maintaining peace in Lagos Waterways.

Challenges facing the Marine Police in the provision of Security in Lagos State

It is quite imperative to note that the department faces a lot of challenges in the provision of Security on Lagos State Waterways on a daily basis. They are constrained by the non-availability of appropriate and adequate logistics support required in meeting the dynamics of the volatile nature of security challenges in the maritime environment.

Some requests of the Marine Police for safer waterways

Dockyard and slipway cradle: Marine Police boats maintenance inevitably requires the availability of docking facilities for regular dry-docking and maintenance. Slipway cradle is needed for the lifting up of boats.

Provision of Back-up boats: The deployment of appropriate patrol back-up boats fitted with 75HP outboard Yamaha Engines to patrol the shallow creeks, where the Gunboats might not be able to reach.

Provision of Station and Observation Post for Marine Police at Ise, Ojo, Ikorodu and Epe: There are major flash points on Lagos state waterways. To this end it is paramount that Marine Police mini posts are built in these areas in order to house personnel at these pin down points. This will frustrate the evil intention of militants/kidnapers, pirates and other criminals on the waterways.

Welfare package for officers and Men: The welfare package for Marine Police personnel should also be reviewed upwards to further boost the morale of the men.

If the above requests of the Marine Police are met, it will go a long way in improving security of the state's waterways for users and residents in general.

A BRIEF ON THE ACTIVITIES OF OP MESA (ARMY, NAVY & AIR FORCE)



A brief report on the activities of Operation Mesa (OP MESA)

Introduction

OP MESA is a Military security outfit which provides support for civil security agencies, especially the Police, in the discharge of their statutory responsibilities. OP MESA comprises officers and men of the Army, the Navy and the Air Force under the command of Brigadier General A.E. Attu, Commander 9 Brigade, Navy Commodore M.A. Eno, Commander NNS Beecroft and Air Commodore M.O. Olatunji Commander Nigerian Air Force 651 Base. The military are currently involved in internal security operations aimed at maintaining law and order in 27 States of the Federation in line with the provisions of Section 217 of the Constitution of the Federal Republic of Nigeria 1999. OP MESA's primary responsibility is anticrime patrol although they participate in joint raids of identified Black Spots with other agencies such as the Police and SSS and in responding to distress calls.

Area of Responsibility

- Army** – Ikoyi, Mile 2, Badagry, Ikeja, Ogba, Ojo, Ikorodu, Mile 12, Ajah, Lagos Island, Idi-Araba, Agbara and oil pipelines in the State.
- Navy** – Agege, Apapa, Ijora, Ajegunle, and some areas of Mile 2 and oil pipelines and tank farms in Lagos State.

- Air Force** – Ikeja, Mushin, Isolo, Apap Ijaye, Oshodi, and Alimosho including Ikotun, Egbeda, Shasha, and its environment.

Mode of Operations of the OP MESA

OP MESA operates a 24 hour daily mobile and static patrols in their predetermined areas of operation which also include public infrastructure.

The State Security Council chaired by His Excellency the Governor coordinates the activities of OP MESA while the state government and the Lagos State Security Trust Fund provide the required operational equipment/assets and logistics for the outfit. The Council ensures that the three (3) arms of the OP MESA function as a unit to ensure the effectiveness of the outfit.

The OP MESA performs regular surveillance patrol in their Area of Responsibility (AOR) and likely black spots as a form of show of Force to deter would be criminals. OP MESA continues to enforce and educate personnel on the need to comply with the ban on motorcycles in some designated areas, the use of tinted glass vehicles and the indiscriminate use of siren in Lagos.

The OP MESA has continued to collaborate with other security agencies to maintain law and order in the State, provide security during public events, such as the House of Representative Bye-Election in Eti-Osa Federal Constituency, and on the internal security operation code named "Crocodile Smile II" which was aimed at flushing out militants, kidnappers, pipeline vandals and other criminal elements in the state.

OP MESA is most grateful to His Excellency the Governor of Lagos State and the Lagos State Security Trust Fund for their support which has enabled the outfit better discharge its responsibility.

Challenges/Requirement

The OP MESA is faced with dire need of vehicular resources, to replace its existing worn vehicles and to expand its fleet. The OP MESA also requires protective gear such as fragmented jackets and helmets to enable them discharge their duties more efficiently.

Conclusion

We are most grateful to His Excellency Governor Akinwunmi Ambode the Governor of Lagos State and The Lagos State Security Trust Fund for the cooperation enjoyed which has made it easy to cope with security challenges in our area of responsibilities.

Report on the audit of the financial statements

Opinion

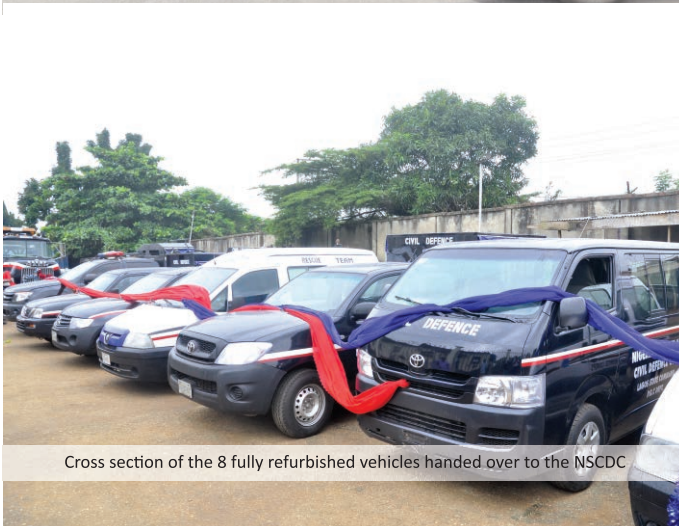

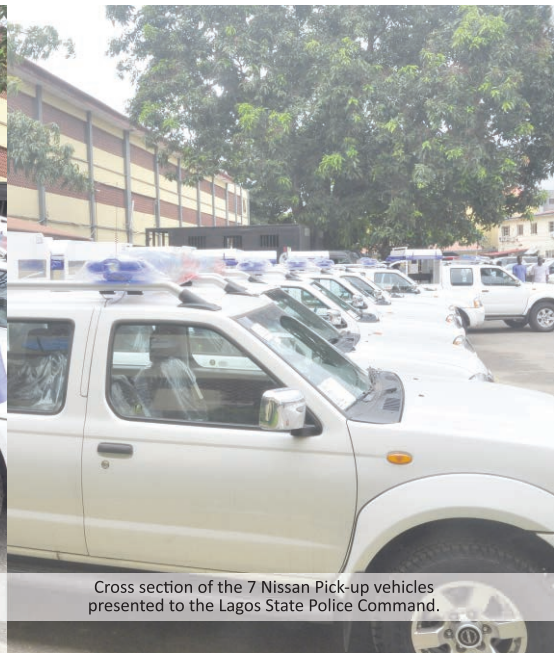
